• \$500 Heat Pump Water Heater Rebates

Heat pump water heater rebates are available to Great Lakes Energy (GLE) members who purchase a qualifying heat pump water heater, and have it installed in the location receiving electric service from GLE.

• Qualifications

Rebates are available to GLE members only. One rebate is allowed per account (meter). The heat pump water heater must be installed at the location where you receive electric service from GLE. Rebates will not be given until after installation at the account location. The system must meet efficiency minimums:

• Energy Factor (EF) or Universal Energy Factor (UEF) ≥ 2.0 required.

Other Rebates

You may qualify for other rebates, too. For more details go to www.gtlakes.com.

Follow these steps in order to receive your rebate:

- 1. Install the heat pump water heater at the location served with electricity by GLE.
- 2. Obtain verification by a licensed contractor. You cannot perform the verification yourself, even if you do the installation. Contact a heating/cooling company or plumber, such as the company you purchased the water heater from to verify installation and fill out the form on the back. The contractor must fill out their portion completely. You are responsible for payment to the contractor for this service call.
- 3. Return the completed form and invoice/sales receipt to GLE.
- 4. GLE will review your submission and, if approved, will issue you a rebate check or credit your electric account within 30 days. **Rebate request must be submitted within 90 days of installation**.
