## Reliability

Fiber is known for being “future-proof,” meaning the fiber we install today will be able to handle increased data loads as the need for more and more bandwidth and speed grows. Fiber technology makes it possible to deliver speeds up to 1 Gig (1,000 Mbps, or megabits per second)—this is 100x faster than what the average home or business can get currently. Fiber is more reliable than other types of networks, less prone to interference and complications from lightning and other natural elements. Studies have shown that fiber also tends to raise the property value of homes.


